

# ICN Merger Working Group Framework for Merger Review Cooperation

### What is the Framework?

- The ICN Framework for Merger Review Cooperation promotes effective and efficient cooperation in multijurisdictional merger review.
- The Framework:
  - > Provides a basis for enforcement cooperation in merger review.
  - Provides contact details for liaison officers at around 60 participating agencies.
  - > Identifies approaches to the exchange of information.

#### What types of information can be exchanged?

- The scope of information exchanged pursuant to cooperation will depend on the specific laws and rules governing confidentiality in each jurisdiction.

### How can you exchange information through the Framework?

- Once you sign on to the framework, you may obtain a <u>member list</u> in which contact information of liaison officers at all participating ICN members are listed.
- You may request information from a specific member authority (or authorities) through the listed liaison officer.

• Cooperation is voluntary and the requested authority provides information at its discretion.
