# Cease and Desist Order against Japanese Consumers' Co-operative Union (Tentative Translation)

July 17, 2008 Japan Fair Trade Commission

The Japan Fair Trade Commission (JFTC) investigated representations related to the clothing sold by Japanese Consumers' Co-operative Union and found that the union was in violation of Item 1 (Misleading Representations about Quality) of Paragraph 1, Article 4 under the Act against Unjustifiable Premiums and Misleading Representations. Accordingly, the JFTC issued today a cease and desist order against the union pursuant to the provision of Paragraph 1, Article 6 of the Act.

#### 2. Outline of the goods specified by the order

Outline of the clothing specified by this cease and desist order is as shown below:

#### 3. Outline of the Cease and Desist Order

#### (1) Outline of the violation

Japanese Consumers' Co-operative Union made the representations as shown in the attached table on its catalogues for 9 clothing items in the same table from around September 2007 at latest to around March 2008. These representations gave the impression that the raw material of these 9 clothing items contained 50% cashmere. In fact, however, only a very small amount of cashmere was used as the raw material for most part of these 9 clothing items.

#### (2) Outline of the cease and desist measures

- A. Japanese Consumers' Co-operative Union should publicly announce that the representations in (1) above gave general consumers the misleading impression that its goods were much better than they actually were.
- B. Japanese Consumers' Co-operative Union should take measures to prevent recurrence and

have these measures thoroughly disseminated to its officers and employees.

C. Japanese Consumers' Co-operative Union should not make similar representations in future.
