Cease and Desist Order and Surcharge Payment Order against Manufacturers and Sellers of Steel Pipe Piles and Steel Sheet Piles (Tentative Translation)

June 4, 2008 Japan Fair Trade Commission

The Japan Fair Trade Commission (JFTC), in accordance with the provisions of the Antimonopoly Act (AMA), has investigated manufacturers and sellers of steel pipe piles and steel sheet piles and found that they have engaged in activities that violate Article 3 (prohibition of unreasonable restraint of trade) of the AMA. Accordingly, the JFTC has today issued a cease and desist order pursuant to the provisions of Paragraph 2, Article 7 of the AMA and a surcharge payment order pursuant to Paragraph 1, Article 7-2 of the AMA.

1. The numbers of companies involved in the violation and companies subject to the cease and desist order and to the surcharge payment order (The names of companies subject to these orders and the amounts of surcharge payable by individual companies and others are specified in Appendix 1.)

2. Outline of the violation

(1) Steel pipe piles

JFE Steel Corporation (hereinafter, "JFE Steel"), Kubota Corporation (hereinafter, "Kubota"), Nippon Steel Corporation (hereinafter, "Nippon Steel") and Sumitomo Metal Industries, Ltd. (hereinafter, "Sumitomo Metal") formed an agreement on specific steel pipe piles (Note 1), according to which:

- a Around February 19, 2004, the base prices per kilogram applicable to contracts from April 2004 onwards would be set equivalent or higher than the prices specified in the Price column of Appendix 2 for different categories of constructors to increase the selling prices for constructors from the conventional levels; and
- b By around March 3, 2005, the base prices per kilogram applicable to contracts from April 2005 onwards would be set equivalent or higher than to the prices specified in the Price column of Appendix 3 for different categories of constructors to increase the selling prices for constructors from the conventional levels.

By entering into this agreement, they substantially restrained competition in the field of

sales for specific steel pipe piles in Japan, contrary to the public interest.

(2) Steel sheet piles

JFE Steel, Nippon Steel and Sumitomo Metal formed an agreement on specific steel sheet piles (Note 2), according to which:

- a Around March 18, 2004, the base prices per kilogram applicable to contracts from April 2004 onwards would be set at 75 yen or more for constructors operating nationwide (hereinafter, "major general constructors") and at 77 yen or more for constructors other than the major general constructors to increase the selling prices for constructors from the conventional levels; and
- b Around February 9, 2005, the base prices per kilogram applicable to contracts from April 2005 onwards would be set at 77 yen or more for major general constructors and at 79 yen or more for constructors other than the major general constructors to increase the selling prices for constructors from the conventional levels.

By entering into this agreement, they substantially restrained competition in the field of sales for specific steel sheet piles in Japan, contrary to the public interest.

- (Note 1) Refers to piles made solely of steel, including those with joints and other fittings and excluding screwed piles, which are used by constructors contracted to perform construction works by the national government, any local government, any corporation a majority of which is owned by the national government or any local government, Hokkaido Railway Company, East Japan Railway Company, Central Japan Railway Company, West Japan Railway Company, Shikoku Railway Company, Kyushu Railway Company or Japan Freight Railway Company for the construction works.
- (Note 2) Refers to those steel sheet piles, excluding those sold to any party engaged in leasing such piles, which are used by constructors contracted to perform construction works by the national government, any local government, any corporation a majority of which is owned by the national government or any local government, Hokkaido Railway Company, East Japan Railway Company, Central Japan Railway Company, West Japan Railway Company, Shikoku Railway Company, Kyushu Railway Company or Japan Freight Railway Company for the construction works.

3. Outline of the cease and desist order

- (1) The companies concerned shall each adopt at their respective boards of directors or other bodies making decisions on business execution a resolution confirming that the agreements mentioned in 2 above have been cancelled and a resolution that they will no longer, among themselves or jointly with any other company, determine the selling prices of the specific steel pipe piles or the specific steel sheet piles for constructors and will separately set such prices at their respective discretion.
- (2) The companies concerned shall each make notification of the measures taken in accordance with (1) above to the other companies concerned as well as to those constructors with which they have transactions and make such measures well-known to their respective employees.
- (3) The companies concerned shall no longer, among themselves or jointly with any other company, determine the selling prices of the specific steel pipe piles or the specific steel sheet piles for constructors.
- (4) The companies concerned shall no longer, among themselves or jointly with any other company, exchange information about a revision to the selling prices of the specific steel

pipe piles or the specific steel sheet piles for constructors.

- (5) The companies concerned shall each take the necessary measures for ensuring that
 - a. Their respective action guidelines on compliance of their activities to sell their products with the AMA will be revised; and that
 - b. Regular training to sales personnel for the specific steel pipe piles or the specific steel sheet piles and regular audits performed by legal affairs personnel will be offered with regard to compliance of their activities to sell their products with the AMA on the basis of the results of the revision mentioned in a. above.

4. Outline of the surcharge payment order

- (1) JFE Steel, Nippon Steel and Kubota shall pay a total amount of 2,030,060,000 yen not later than September 5, 2008 (see Appendix 1).
- (2) In accordance with the provision in Paragraph 2, Article 4 in the Supplementary Provisions of the Amended Antimonopoly Act (Act No. 35 of 2005), a surcharge rate of 6% is applied to the amount of sales earned before January 4, 2006, when the aforementioned legislation came into force, for calculation of the amount of surcharge.
