Call for Information on the Impact of a Merger between Nippon Steel Corporation and Sumitomo Metal Industries, Ltd., on Competition

On May 31, 2011, the Japan Fair Trade Commission (hereinafter the "JFTC") received a submission related to a merger as provided in Paragraph 2, Article 15, of the Antimonopoly Act submitted by Nippon Steel Corporation ("Nippon Steel") and Sumitomo Metal Industries, Ltd. ("Sumitomo Metals"), and accepted the submission on the same day.

Upon conducting a review of the business combination, the JFTC has decided to call for information from third parties, including those in the same industry and business partners, on the impact on competition if the said merger actually takes place.

## 2. Contents of information sought

Please note as specifically as possible what sort of impact is foreseen with which product (including services; hereinafter the same) if the said merger actually takes place. (Note 2) Examples include, but are not limited to, beliefs that the price would go up (down), the quality would be enhanced (deteriorate), the choices would widen (narrow), technological innovations would be promoted (stagnate), and procurement would be facilitated (made more difficult) with product XX. (Note 3)

Note 2: The impact on competition includes products manufactured and sold not only by the business entities concerned but also their subsidiaries, affiliates, etc. The products that the business entities concerned (including their subsidiaries, affiliates, etc.) are competing with are as shown in Attachment 1, but specific methods of products do not need to be exactly the same. Attachment 1 shows examples, and we also accept information on products not listed in Attachment 1.

Note 3: We might contact you for inquiries about the information you sent in.

## 3. Closing date for information provision

We ask that the information you send in arrives by Wednesday, June 15, 2011. However, we will continue accepting your response during the reviewperiod (Note 4), even after the closing date.

We will make a notice on the JFTC's website when the acceptance of information has been closed.

Note 4: The flow of statutory procedures for plans on business combination is as shown in Attachment 2.

#### 4. Handling of information

The JFTC will use the information sent in only for the purpose of the review and will not

disclose the information in any way that may identify the person who sent in the information to the business entities concerned or any other party. Please note that the JFTC will not send responses.
