## The 4th East Asia Conference on Competition Law and Policy and

The 3rd Top Level Officials' Meeting on Competition Policy

April 25, 2007 Japan Fair Trade Commission

In cooperation with the Vietnam Competition Administration Department of the Ministry of Commerce (VCAD) and the Asian Development Bank Institute (ADBI), the Japan Fair Trade Commission (JFTC) will hold the 4th East Asia Conference on Competition Law and Policy on May 3rd, and will also hold the 3rd Top Level Officials' Meeting on Competition Policy on May 4th, in Vietnam, Hanoi.

The East Asia Conference on Competition Law and Policy is organized for the purpose of developing a common understanding on importance of competition law and policy in the East Asian region. The 1st meeting was held in Kuala Lumpur, Malaysia in March, 2004, the 2nd meeting was held in Bogor, Indonesia in May, 2005, and the 3rd meeting was held in Bangkok, Thailand in June, 2006.

The Top Level Officials' Meeting on Competition Policy is organized for the purpose of strengthening the cooperative relationship among competition authorities/competition related authorities through frank exchange of views and information among the top level officials of competition authorities/competition related authorities. The 1st meeting was held in Bogor, Indonesia in May, 2005 and the 2nd meeting was held in Bangkok, Thailand in June, 2006.

This year, seventeen authorities from ASEAN member economies, Japan, etc. will participate in the both conferences.
